Federal and Oregon Law restricts issuance of Concealed Handgun Licenses to adults 21 years or older with: no criminal record, no history of domestic violence, and no mental illness.

Due to the nature of the course no persons under 21 will be allowed in the class

The course will stress handgun safety and will satisfy the training requirement for your subsequent application for an: (1) Oregon Concealed Handgun License (CHL), (2) Utah Concealed Firearm Permit (CFP), (3) Arizona Concealed Weapon Permit (CWP), and/or (4) Florida Concealed Weapon License (CWL). Your completion of this class will be documented by an endorsement in writing by your certified instructor. The following fee schedule covers this training and endorsement(s) only. It does not cover the fee charged by respective states for concealed carry permits:

One (1) Endorsement: Oregon CHL Only - \$50 or 1 Other - \$80 Two (2) Endorsements: OR CHL + 1 Other - \$100 or 2 Other - \$115 Three (3) Endorsements: OR CHL + 2 Others - \$130 or 3 Other - \$150

Four (4) Endorsements: OR CHL + 3 Others - \$160

Applications should be received by the Monday preceding the Saturday class. You are pre-registered when your fee is received. If you've pre-registered but can't attend, let us know as soon as possible to be moved to a subsequent class. If not pre-registered by Monday - call.

Arrive by 8:30am to complete registration and begin fingerprints and photos. Instruction begins at 9:00am. Instruction is organized in 4 one-hour segments, each ending with a 10-minute break. At noon the lunch break is longer. Bring a sack lunch. Instruction is concluded with the individually coached Live Fire Exercise. Expect to finish by/before 4pm. Please dress appropriately for (unheated) firing range.

Upon arrival bring your **unloaded** handgun for the live fire exercise to the gun inspection table. Also bring a fifty-round box of fresh **commercial ammunition** of the correct caliber for your handgun (**no hand-loads**, **no factory re-loads**). If you don't have a handgun, you're still welcome; we recommend the live fire exercise but it's not a requirement for training endorsement(s).
